Legislative Advisory #2

Governor John Carney signed the following legislation on the date indicated:

HJR #3 (3/22/17) – DIRECTING THE DEPARTMENT OF EDUCATION TO REVIEW THE STATE ESSA PLAN WITH THE EDUCATION COMMITTEE OF THE HOUSE OF REPRESENTATIVES AND THE SENATE. (Sponsors: Rep. Jaques & Sen. Sokola).
