Legislative Advisory #6

Governor John Carney signed the following legislation on the date indicated:

HB #114 AAB House Amendment #1 (6/13/17) – AN ACT TO AMEND TITLE 21 OF THE DELAWARE CODE RELATING TO BODILY INJURY AND PROPERTY DAMAGE COVERAGE ON MOTOR VEHICLES. (Sponsors: Rep. B. Short & Sen. Sokola & Reps. Keeley, Mitchell & Paradee). (Volume 81, Chapter 39, Laws of Delaware).
