Legislative Advisory #35

Governor John Carney signed the following legislation on the date indicated:

HJR #13 (7/25/18) – REQUIRING ANY INSURANCE COMPANY OR HEALTH SERVICE CORPORATION SELLING INDIVIDUAL AND SMALL GROUP MARKET INSURANCE PRODUCTS IN DELAWARE TO FILE A REPORT DETAILING HOW THEY DISTRIBUTED SAVINGS TO DELAWARE CONSUMERS IN PLAN YEAR 2019 FROM THE FEDERAL GOVERNMENT’S ONE YEAR MORATORIUM OF THE INSURANCE COMPANY FEE CREATED BY THE PATIENT PORTABILITY AND AFFORDABLE CARE ACT OF 2010 TO DELAWARE CONSUMERS IN PLAN YEAR 2019. (Sponsors: Rep. Schwartzkopf and Sens. McBride & Henry & Poore & Simpson & Lavelle & Bushweller & Townsend & Reps. Longhurst & Viola & D. Short & Hudson & Bentz & B. Short)

SB #246 AAB HA #1 & SA #1 (7/25/18) – AN ACT TO AMEND TITLES 9 AND 22 OF THE DELAWARE CODE RELATING TO COUNTIES, MUNICIPALITIES AND PUBLIC LANDS. (Sponsor: Sen. McDowell) (Volume 81, Chapter 361, Laws of Delaware).

SB #233 (7/25/18) – AN ACT TO AMEND TITLE 21 OF THE DELAWARE CODE RELATING TO SPECIAL STOPS REQUIRED AT RAILROAD CROSSINGS. (Sponsors: Sen. Hansen and Rep. Osienski) (Volume 81, Chapter 362, Laws of Delaware).

SB #175 AAB SA #1 (7/25/18) – AN ACT TO AMEND TITLE 30 OF THE DELAWARE CODE RELATING TO WITHHOLDING OF INCOME TAX ON SALE OR EXCHANGE OF REAL ESTATE BY NONRESIDENTS. (Sponsors: Sen. Bushweller and Reps. Paradee & M. Smith) (Volume 81, Chapter 363, Laws of Delaware).

SJR #7 (7/25/18) – ESTABLISHING A WORK A DAY EARN A PAY PILOT PROGRAM WITHIN THE DEPARTMENT OF TRANSPORTATION. (Sponsor: Sen. Marshall)

SB #185 (7/26/18) – AN ACT TO AMEND TITLE 21 OF THE DELAWARE CODE RELATING TO SPECIAL LICENSE PLATES. (Sponsor: Sen. Simpson) (Volume 81, Chapter 364, Laws of Delaware).

SB #208 AAB SA #1 (8/6/18) – AN ACT TO AMEND TITLE 29 OF THE DELAWARE CODE RELATING TO PUBLIC WORKS CONTRACTING. (Sponsors: Sen. Poore and Rep. Jaques) (Volume 81, Chapter 365, Laws of Delaware).
