With this money AOD will hire a full time Behavior Interventionist to work with students and staff on promoting positive behavior within the building, on the playground, on the bus, etc. This Behavior Interventionist will keep documentation of all behavior referrals, input data into Eschool, contact parents regarding student behavior, serve on the PBS team, participate on the behavior IST team and Behavior IEP meetings, as well as work with staff to resolve different student behavioral issues in the classroom.
This will be a full time salary position.
