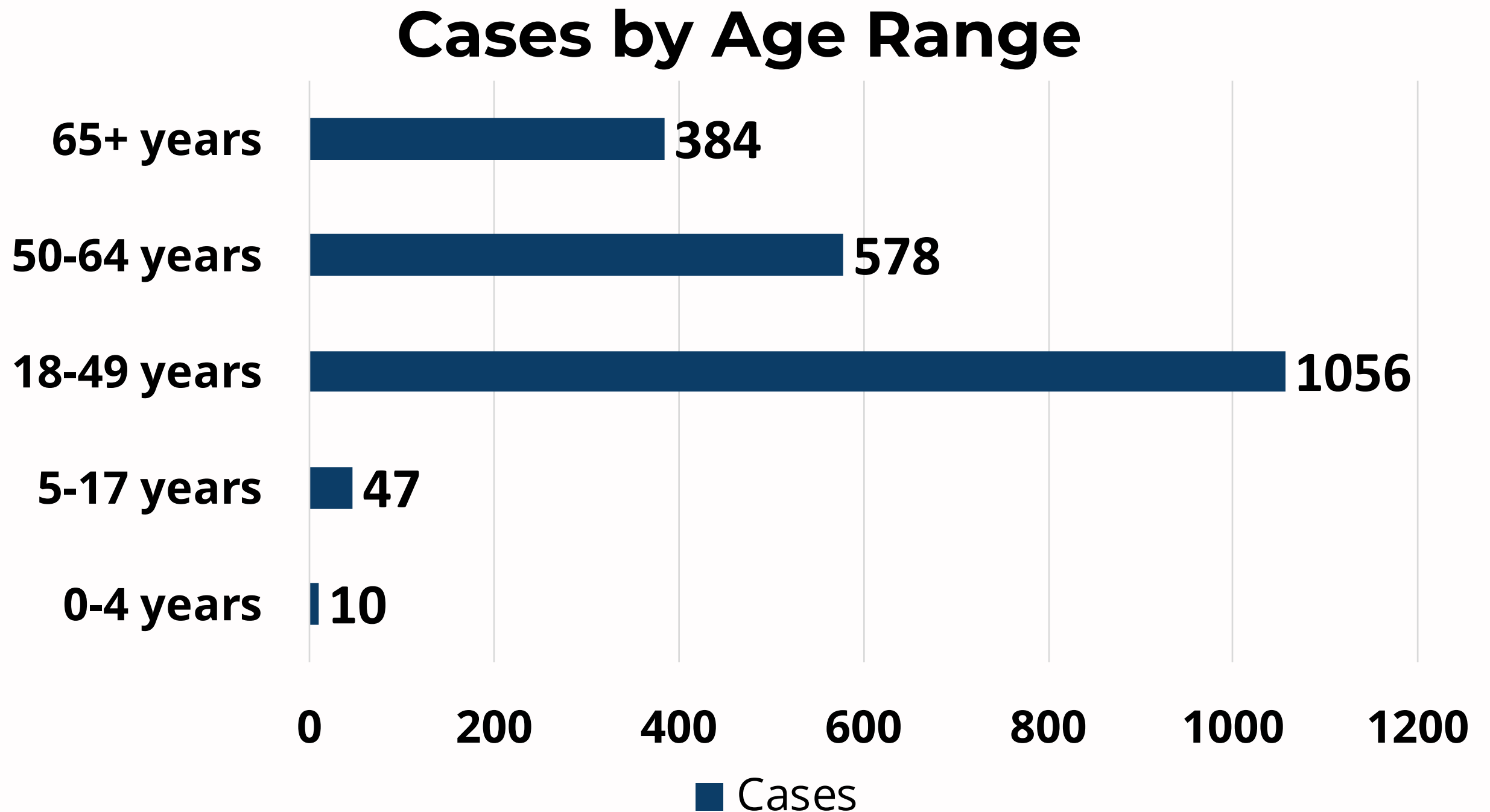

Timeline of Delaware's Response

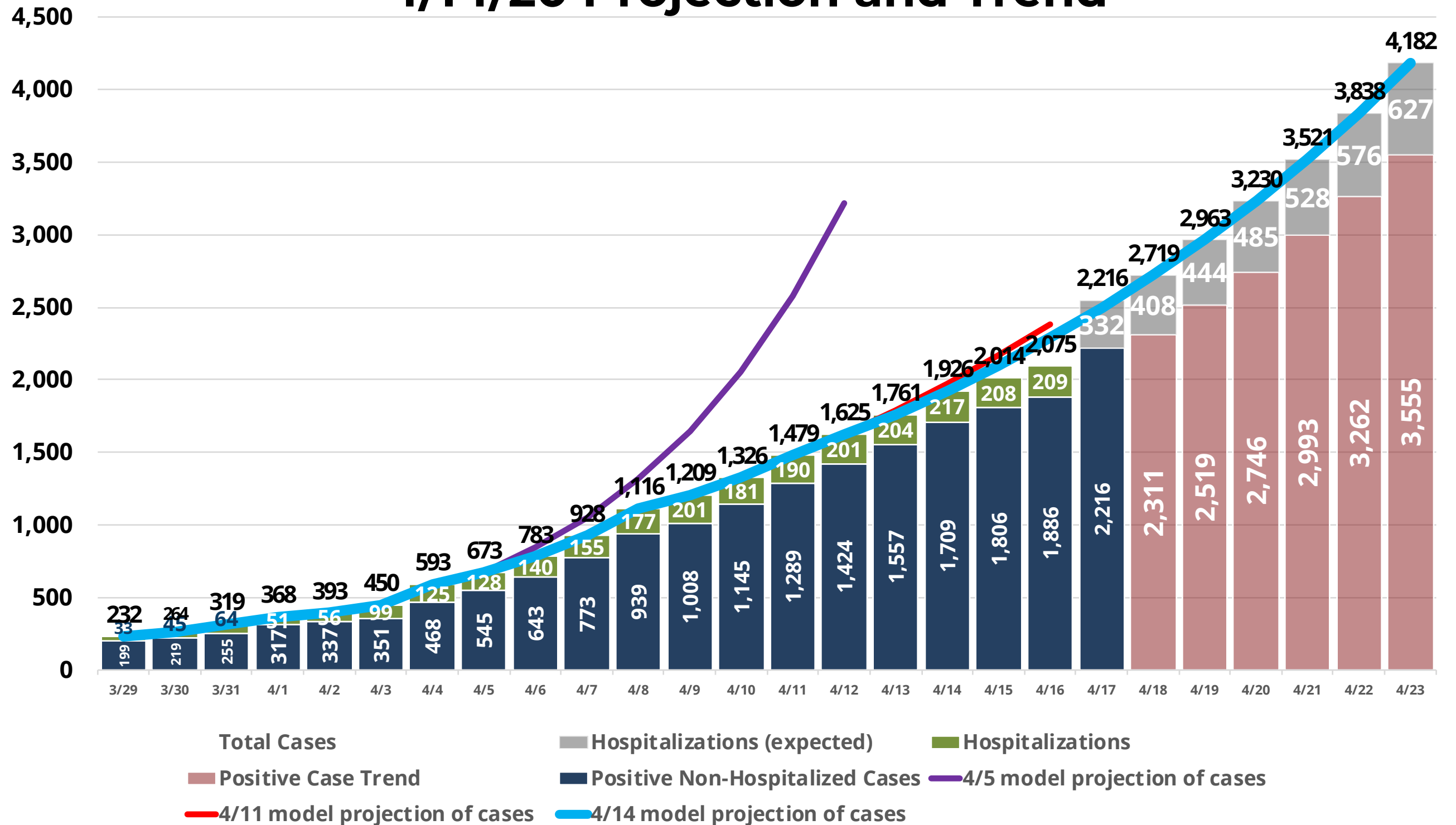
- ✓ **MARCH 11**
First confirmed positive case of COVID-19
- ✓ **MARCH 12**
State of Emergency Declaration
- ✓ **MARCH 16**
Closed restaurants and bars
- ✓ **March 21**
Closed Delaware beaches
- ✓ **MARCH 22**
Stay-At-Home Order
- ✓ **MARCH 23**
Schools closed until May 15

- ✓ **MARCH 29**
Out-of-state travelers to self-quarantine for 14 days
- ✓ **APRIL 1**
Additional business restrictions
- ✓ **APRIL 2**
Community Call-to-Action for supplies and materials
- ✓ **APRIL 6**
Banned short-term and commercial rentals
- ✓ **APRIL 15**
Stricter measures in long-term care facilities

Education

- **Schools remain closed until May 18**
- **Not enough information yet** to make a decision to close remainder of the year
- **Regular communication** with Superintendents
- Schools remain **focused on remote learning**

Restarting the Economy

WHAT NEEDS TO HAPPEN FIRST:

- 14 days of **declining symptoms, presumed cases**
- 14 days of **declining hospitalizations**
- Ability to treat COVID-19 patients **in hospitals without crisis care**
- Extensive **testing programs** for health care workers

Restarting the Economy

TO GET THERE, WE NEED:

- **Widespread testing**
- **Contact tracing and surveillance** for older Delawareans, lower-income communities, and minority populations
- Adequate supply of **personal protective equipment**
- Protecting **health and safety of workforce**
- Public guidance on **social distancing and face coverings**
- **Constant monitoring** of situation to mitigate new outbreaks

Restarting the Economy

MITIGATION ACTIONS THAT WILL REMAIN DURING PHASES OF RESTART

- **Social distancing**
 - *Requiring at least 6 ft. in retail stores*
- **Face coverings in public**
- **Hygiene**
 - *Access to hand washing or sanitizing stations*
 - *Don't touch your face*
 - *Don't shake hands*
- **Limited gatherings**
- **Vulnerable populations to shelter in place**

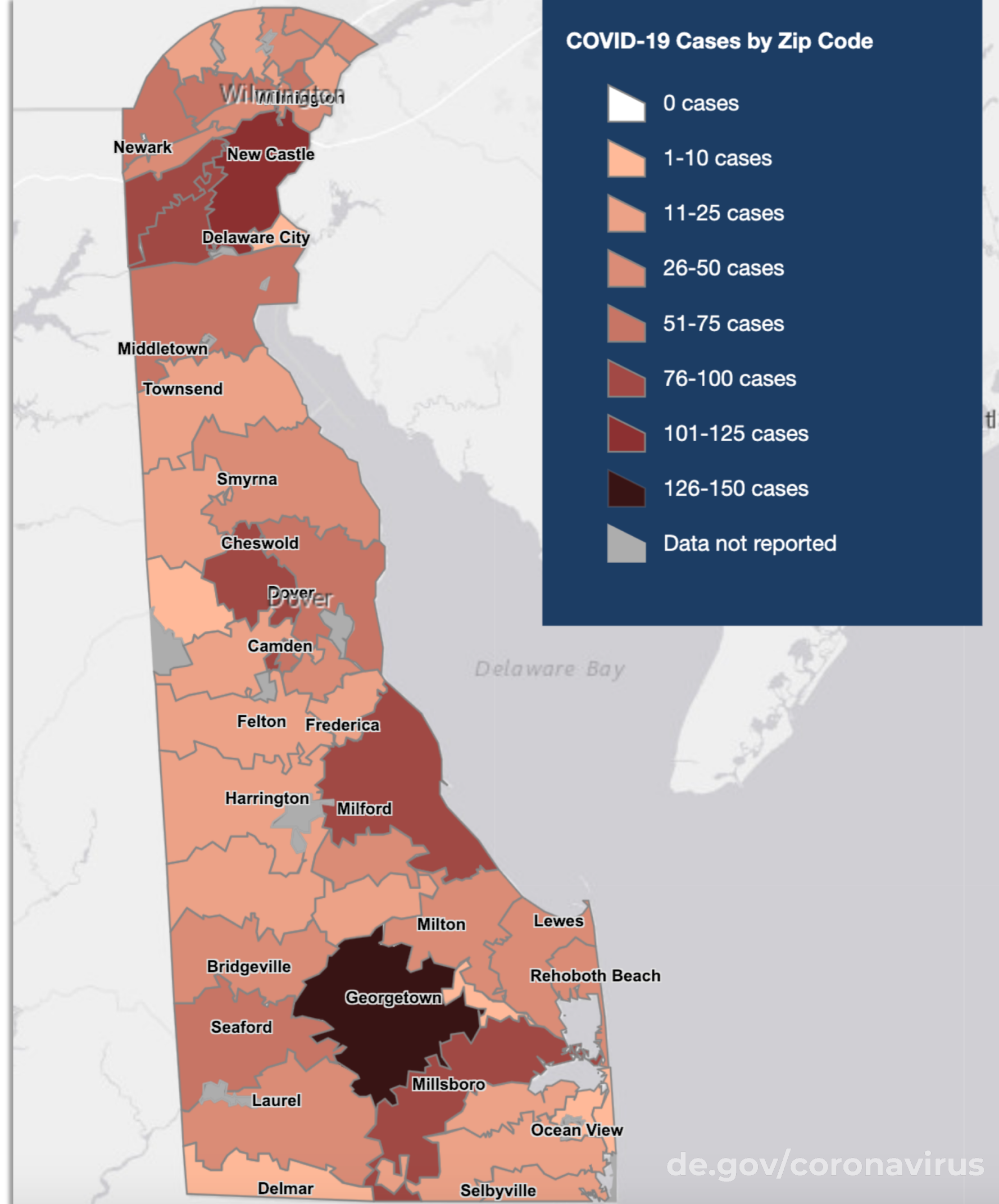

- **Total Hospital Tests – 15,248**



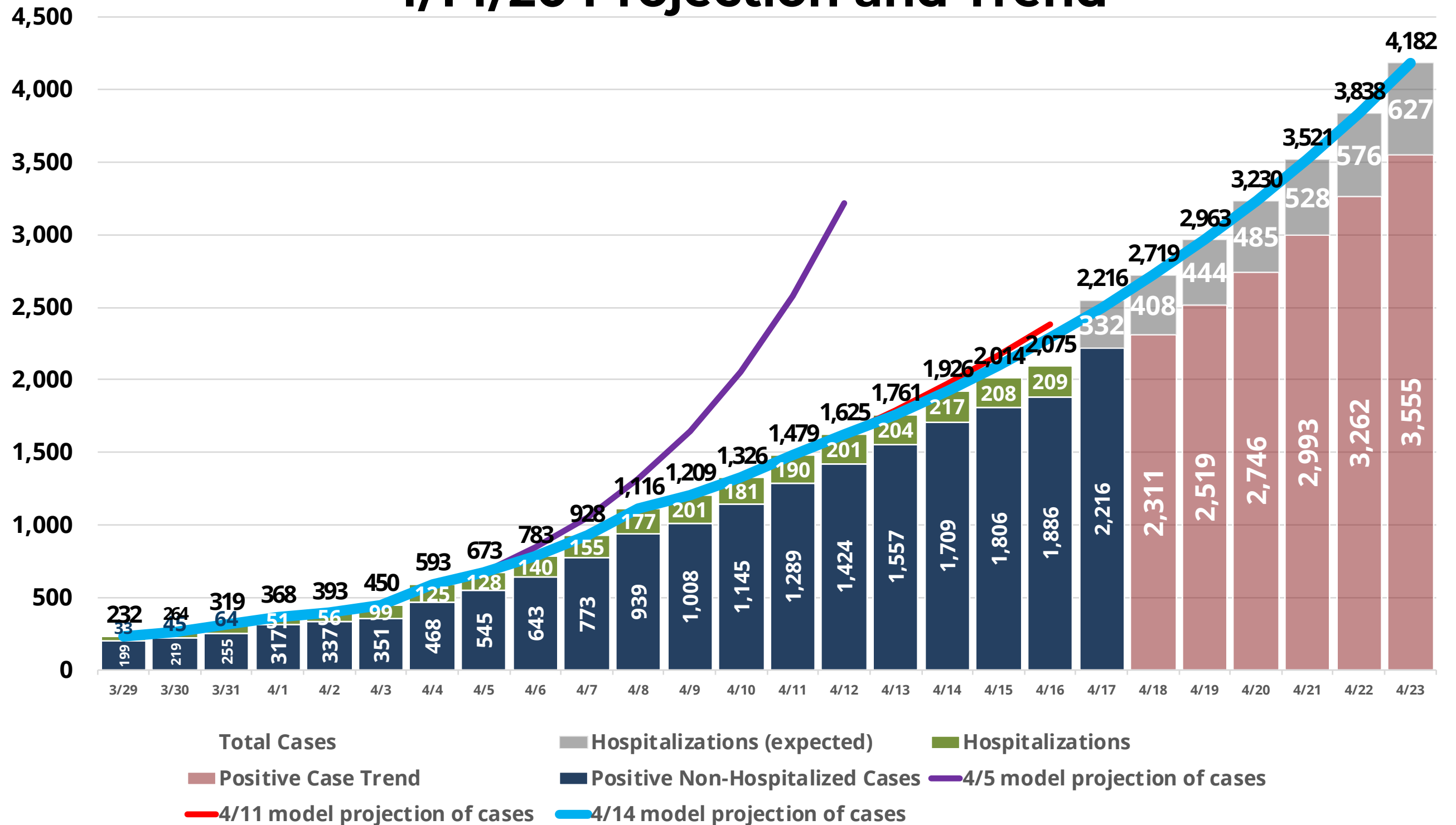
