Legislative Advisory #33

Governor John Carney signed the following legislation on the dates indicated:

**HB #232 (8/25/20)** – AN ACT TO AMEND TITLE 10 AND TITLE 25 OF THE DELAWARE CODE RELATING TO JURISDICTION OF THE JUSTICE OF THE PEACE COURT AND SUMMARY POSSESSION. (Sponsors: Rep. Matthews & Sen. Poore). (Volume 82, Chapter 282, Laws of Delaware).

**HB #335 (8/25/20)** – AN ACT TO AMEND TITLE 12 OF THE DELAWARE CODE RELATING TO RESTRICTED ACCESS TO SAFE DEPOSIT BOXES FOR RETRIEVAL OF DECEDENT'S LAST WILL AND DECLARATION OF LAST REMAINS. (Sponsors: Rep. Bush & Sen. Paradee & Rep. Dorsey Walker & Rep. Griffith & Rep. Hensley & Rep. Lynn & Rep. Ramone & Rep. Spiegelman & Sen. Delcollo & Sen. Hansen & Sen. Sokola & Sen. Townsend). **HB #353 (8/25/20)** – AN ACT TO AMEND TITLE 19 RELATING TO NON-CHARGING OF COVID-19 RELATED UNEMPLOYMENT BENEFITS TO EMPLOYERS. (Sponsors: Rep. Osienski & Sen. Walsh). (Volume 82, Chapter 285, Laws of Delaware).

**SB #169 AAB SA #1 (9/23/20)** – AN ACT TO AMEND TITLE 10 OF THE DELAWARE CODE RELATING TO THE DELAWARE UNIFORM CIVIL REMEDIES FOR UNAUTHORIZED DISCLOSURE OF INTIMATE IMAGES ACT. (Sponsors: Sen. Hansen & Rep. Griffith & Rep. Bennett & Rep. Dorsey Walker). (Volume 82, Chapter 286, Laws of Delaware).
