Legislative Advisory #1

Governor John Carney signed the following legislation on the date indicated:

**HB #65 (2/8/21)** – AN ACT TO AMEND TITLES 19, 29 AND 30 OF THE DELAWARE CODE RELATING TO COVID-19 RELATED UNEMPLOYMENT BENEFITS, ASSESSMENTS AND RULEMAKING AUTHORITY. (Sponsors: Rep. Osienski & Rep. Bush & Rep. K. Williams & Rep. Schwartzkopf & Rep. Longhurst & Rep. Mitchell & Rep. Matthews & Rep. Baumbach & Rep. Bennett & Rep. Heffernan & Rep. Morrison & Rep. K. Johnson & Rep. **SB #33 (2/10/21)** – AN ACT TO AMEND TITLE 26 OF THE DELAWARE CODE RELATING TO RENEWABLE ENERGY PORTFOLIO STANDARDS. (Sponsors: Sen. Hansen & Sen. S. McBride & Rep. Osienski & Rep. Heffernan & Rep. S. Moore & Rep. Bush). (Volume 83, Chapter 3, Laws of Delaware).
