#### **GENERAL OVERVIEW**

The State of Delaware received \$924,597,608 through the State and Local Fiscal Recovery Fund (SLFRF) provided through the American Rescue Plan Act (ARPA). This report details how the funds have been spent to date, as well an overview of how Delaware plans to allocate ARPA SLFRF monies to help the state recover from the COVID-19 pandemic and the resulting economic downturn.

#### **EXECUTIVE SUMMARY**

Delaware's focus for allocating its ARPA funds is to invest in projects that address the healthcare, mental health, economic recovery, and employment needs caused by and/or exacerbated by the COVID-19 pandemic. To date, Delaware has awarded more than \$135 million of the nearly \$925 million it received in ARPA funding, with an additional \$600 million committed to specific projects that will have significant impacts on the state's pandemic recovery for years to come.

It is important to note the rigorous review process Delaware has established for every proposed ARPA-funded project. The ARPA Delaware team worked with the Delaware Department of Justice to develop a detailed Worksheet that every applicant for funding must complete to demonstrate the proposed project meets the strict federal ARPA requirements. An APRA Worksheet for every project is then reviewed by deputy attorneys general in the Delaware Department of Justice, with a written compliance opinion stating that eligibility requirements have been met. No awards are made to any organization without this review to ensure the project is an eligible use of funds through ARPA SLFRF.

Furthermore, the ARPA Delaware team worked with attorneys in the Delaware Department of Justice to create a subrecipient agreement that organizations must sign before receiving ARPA funds for projects that have been deemed eligible. Along with the subrecipient, this agreement is signed by Delaware's Secretary of Finance and Director of the Office of Management and Budget.

ARPA Delaware also implemented compliance reviews and project status update meetings for every project that receives ARPA funding. The compliance reviews include project status questionnaires to capture and compare quarterly progress. Over the next six months, ARPA Delaware will further enhance compliance and status checks, including expertise from contracted compliance firms to assist with more detailed reviews and complex, multi-year projects. The goal of these reviews is to ensure compliance with ARPA Rules, monitor progress of projects, and obtain data that will help showcase the impact of these funds.

We are researching opportunities to help advance economic development opportunities and may utilize a portion of the "State Revenue Loss" from calendar year 2020 to further support economic development projects.

**Progress to Date on Outcomes** – While several projects are still in the early planning and design phases, we have numerous projects underway that already are making an impact across the state. These projects are boosting employment, increasing vaccination rates, delivering temporary housing relief, providing relief to hospitals, long-term care facilities, and federally qualified health centers, and providing more resources and relief to those in need throughout Delaware.

Challenges/Opportunities Identified During the Reporting Period – Throughout this reporting period, we have provided funding to dozens of state agencies and nonprofit organizations to address the needs of citizens across the state and provide impactful results. We have not identified any challenges but will be prepared for any challenges that may arise in the future.

#### **USES OF FUNDS**

#### a. Public Health

To help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn, Delaware has invested in several public health measures, including but not limited to: COVID testing and vaccination programs, public health surveillance, continued COVID-19 mitigation efforts in congregate living facilities and schools, behavioral healthcare for children, youth and adults, mental health treatment services, domestic violence awareness, capital investments to improve ventilation systems in state facilities, food bank resources to those in need, and the construction of new clinical laboratories.

We have and will continue to focus on measures that support a strong and equitable recovery and meet specific needs of communities, populations, and individuals hardest hit by the pandemic and the resulting economic downturn.

Delaware has made significant capital investments to improve the air quality in three maximum and medium-security correctional institutions in the State, as well as investments to improve the air quality in other state-owned buildings across the state. These investments will enable better air quality and flow to assist in the prevention of COVID-19 and other airborne illnesses. The State also has dedicated \$50 million to community-based mental health care services. A new food warehouse will provide food to families in need and work with organizations throughout the state to confront hunger issues in the most vulnerable neighborhoods. Clinical laboratories will be developed through collegiate partners as well as the Division of Public Health (DPH) and Department of Natural Resources and Environmental Control (DNREC). These labs will serve citizens throughout the state by conducting needed research into the prevention and treatment of diseases, behavioral research, neuroscience, and other areas of need.

#### **b.** Negative Economic Impacts

To help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn, Delaware has and will continue to invest in economic development and community projects, including but not limited to, job training, compensation incentives for healthcare facilities to regain full employment, workforce development for small businesses, replenishing the Unemployment Insurance Trust Fund to the pre-pandemic level, addressing health disparities and social determinants of health, addressing educational disparities caused or exacerbated by the pandemic, investing in neighborhoods and affordable housing programs, enhancing child care and senior care services.

\$50 million has been dedicated to workforce development initiatives throughout the State through the Forward Delaware Workforce Development Fund. We have and will continue to promote job training and workforce development for the citizens of Delaware.

Over \$100 million has been dedicated to creating affordable housing opportunities across the State. These projects will help address the critical housing shortage and provide affordable housing to countless families in need that have been the most vulnerable throughout the COVID-19 pandemic.

Additional projects dedicated to assist childcare, small businesses, non-profits, and impacted industries have begun as well. These projects include new childcare and innovation centers for Delaware State University and Delaware Technical and Community College, a new facility to address educational disparities and after-school activities for students in the City of Wilmington, and economic relief to impacted industries in hard-hit areas.

#### c. Public Health-Negative Economic Impact

To help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn, Delaware has and will continue to invest in the public sector workforce and capacity. Funds have been used to fulfill staffing issues and increase the workforce for positions that were depleted due to the COVID-19 pandemic. For instance, staffing shortages were addressed for specific workforces such as correctional officer, nurses, and school staffing. These projects have allowed the State to increase staffing and ensure vital services are made available to the public.

In addition to assisting staffing issues and an increased workforce, several projects have been undertaken to allow for better service delivery such as the digital government platform allowing employees to work safely from a remote location and updated meeting rooms to allow for updated technology so virtual meetings can take place to reduce the potential transmission of COVID-19. Learning management systems and health data systems will be developed to provide accurate, real-time information to the general public and citizens across the State.

#### d. Premium Pay

In the hard-to-fill, high-demand jobs in Delaware's correctional system, Delaware used a small portion of its ARPA SLFRF monies for premium pay in the form of retention bonuses for correctional officers.

# e. Water, sewer, and broadband infrastructure

To help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn, Delaware has invested ARPA funds towards a Broadband Last Mile project. Delaware aims to be the first state in the nation to provide broadband access to every home in the State. This project also provides temporary broadband to students across the state through Connect DE to ensure students have access to high-speed internet.

#### f. Revenue Replacement

To help support a strong and equitable recovery from the COVID-19 pandemic and economic downturn, Delaware is researching opportunities to help advance economic development opportunities and may utilize a portion of the "State Revenue Loss" from calendar year 2020 to support. Delaware's calculated State Revenue Loss is \$210,724,617.

Emergency Rental Assistance Program (ERA): \$96 million available, with more than half of that amount disbursed to date. These funds are being used for Rental Assistance, Utilities and Home Energy Costs and Arrears, Housing Stability Services.

NOTE: Eligible households as defined in statute – renter households below 80% of Area Median Income, qualified for unemployment or with COVID-19 related financial hardship, risk of housing instability or homelessness.

**Homeowner Assistance Fund: \$50 million**, being used for Mortgage Assistance, Utility Assistance, Housing Stability Services for homeowners

#### **HOME Homeless Funding:**

\$5.4 million to Delaware State Housing Authority \$3.7 million to New Castle County Housing Authority \$2.1 million to Wilmington Housing Authority

#### These funds:

- Flow through the HOME Investment Partnerships Program and follow its regulatory structure
- Tenant based Rental Assistance (TBRA)
- Development and support of affordable housing as currently permitted under HOME
- Supportive services including transitional housing, housing counseling, prevention services
- Acquisition & development of non-congregate shelter units

NOTE: Eligible recipients: homeless, at risk of homelessness, fleeing or attempting to flee domestic violence, etc.; Individuals for whom supportive services or assistance would prevent homelessness and at are at greatest risk of housing instability.

#### PROMOTING EQUITABLE OUTCOMES

#### a. Goals:

Delaware is working with communities hardest hit by the pandemic in all parts of the State to help underserved, marginalized or adversely affected groups. For example, we have a number of housing, economic development, community investment, and workforce development projects focused in each county. These projects will serve the hardest hit areas and most vulnerable communities such as the City of Wilmington, Georgetown, Dover, and other areas across the State.

#### b. Awareness

Delaware has worked closely with legislators, mayors, religious leaders, nonprofit organizations, and the business community to promote equitable and practical access and awareness to SLFRF. We are utilizing existing, efficient and effective entities, such as Downtown Development Districts, to promote access and awareness of SLFRF. We have conducted significant outreach, utilized census track data, and made significant progress in the distribution of funds to areas most in need. The Governor, state legislators, members of the federal congressional delegation, other state and local elected leaders, community advocates, business and community leaders have participated in numerous new conferences, announcements, press releases and social media posts to promote ARPA projects and funding, and we will continue to provide outreach and promote awareness of the spending of how ARPA funds are helping people across our state.

#### c. Access and Distribution

One advantage of a small state is that we can break down barriers of access to benefits and services. We aim to provide the same levels of access to benefits and services to all individuals throughout the State and serve the most vulnerable in our communities.

Delaware has not experienced and does not anticipate administrative requirements that result in disparities in ability to complete applications or meet eligibility criteria.

#### d. Outcomes

Intended outcomes are focused on closing gaps in employment, poverty, access to healthcare, access to broadband, and communities hardest hit by the pandemic. By working with many groups across the State we have been able to identify the hardest-hit and most vulnerable areas. We are using the ARPA funds to help more people with job training, to find and keep high-paying jobs, provide access to affordable housing, and provide access to quality healthcare services and mental health services. Entities that receive ARPA funds report demographic information, such as race, ethnicity, and income levels, to help the state track the impact of ARPA-funded projects.

#### **Equity Goals and Targets**

We have worked with state agencies, nonprofit organizations, community groups and others to provided needed assistance to the most vulnerable communities and people in need. For instance, multiple workforce development projects have been created to provide training and development for women and minorities in the workplace. These goals and objectives will focus on bridging the economic and racial equity gap in the workplace. The affordable housing projects will focus on providing housing relief to those in need prioritizing economic and racial equity. Demographic information will be collected as part of these projects so that meaningful results are achieved. The ARPA Delaware team is conducting compliance monitoring of each project so that each project stays on track and delivers expected results.

#### **Project Implementation**

Delaware has worked with partners throughout the state to create a multitude of projects that address various issues such as assistance to households, small businesses, and non-profit organizations.

Several projects will provide assistance to households in the form of food programs, such as a food warehouse, and funding to non-profits to provide food and other necessities to communities in need. One of these projects will work with local farmers and food providers to provide grant funding that will be used to increase the food supply and assist the public with food shortages.

Affordable housing and emergency housing assistance projects will provide housing security to those in need, including building new affordable housing units. Families in need also are provided emergency housing support to prevent homelessness and assist them toward more permanent housing.

Other projects will focus on addressing educational disparities and providing childcare and learning services. For instance, one project will help inner city youth in Wilmington by providing after school tutoring and educational support. These programs are designed to increase graduation rates and long-term success for children in Delaware.

#### **Project Outcomes**

As more projects progress, we will see more results and achieve equitable outcomes. Many projects are in the early stages and project outcomes will become more substantial as the projects progress. Some of the projects are already showing results. For instance, in one project that provides training to jobseekers, four clients have completed training and increased their average salary from approximately \$37,000 per year to \$77,000 per year. This project has 11 clients currently enrolled and projected to complete the training in September 2022. Another workforce development project funded summer youth employment programs for 475 young adults. In another example to boost employment in Delaware's restaurant industry, ARPA funds provided trainings to 2,059 restaurant workers, with another nearly 1,500 enrolled in restaurant trainings.

#### **COMMUNITY ENGAGEMENT**

Delaware's Governor, state legislators, members of the federal congressional delegation, other state and local elected officials, Cabinet Secretaries, nonprofit organizations, community and business leaders have been actively engaged in ARPA plans and projects. To further engage the community and create awareness of the funding opportunities, the Delaware ARPA team created several application processes for nonprofit organizations to apply for ARPA funding.

#### LABOR PRACTICES

ARPA-funded projects follow the State's prevailing wage requirements and labor agreements based on the State law.

#### **USE OF EVIDENCE**

Evidence-based models will be incorporated in many SLFRF projects as a means of program evaluation. By implementing and bolstering the leading strategies and science in the fields of mental health, job training, community engagement and housing support, our projects will have a strongest and lasting impact to help Delaware's vulnerable citizens and communities. Each project will target impacted populations with tailored and focused strategies to meet their needs. As projects move beyond the planning phase, data related to client demographics, especially for impacted communities and populations, will be evaluated to make sure services are reaching the targeted populations. Job training initiatives, mental health services and community intervention programs will be evaluated and judged based on reaching the most vulnerable populations within our communities centered around the design and objectives laid out in each subrecipient agreement. ARPA Delaware will monitor stated goals through detailed compliance reviews, including reviews of contracts, grant agreements, invoices, and short and long-term trends. In addition to the financial review the ARPA Delaware team will use quarterly compliance and project status updates to gather data on demographics, client satisfaction and project completion goals and percentages.

#### PERFORMANCE REPORT

As we progress in the distribution and dedication of funds, we are tracking all projects to monitor key objectives and goals. We have grouped projects in the following categories: Affordable Housing, Broadband, Community Investment, COVID Testing and Pandemic Response, Higher Education, Hospital and Long-Term Care Facility Support, Mental Health Services, Premium Pay and Public Sector Workforce, Revenue Replacement, Safer Delaware, State Capital, and Workforce Development.

We also are contracting with firms to assist the ARPA Delaware team with compliance monitoring of subrecipient agreements to track the projects' performance and results. Demographic data will be collected through these review processes.

All projects are posted on our website (<a href="https://governor.delaware.gov/rescue-plan/">https://governor.delaware.gov/rescue-plan/</a>) with a brief description capturing the purpose the project as well as the budget and current expenditures for each project. Project information is updated on a monthly basis to capture the most updated information available. An Internal Compliance Review Policy has been developed and is posted on our website. **Affordable Housing:** This group of projects is in the award phase and no projects have been started as of June 30, 2022. As awards are issued, frequent reporting and compliance monitoring will occur to ensure the overarching goals of affordable home ownership are met.

**Broadband:** This project has provided access to high-speed internet 164 homes and locations that previously had no or limited broadband access. In addition to providing high-speed broadband internet, Connect DE provides temporary high-speed internet to areas in need where high-speed internet is currently not accessible.

**Community Investment:** The majority of these projects are underway, and others may be awarded in the future. Each of these projects has routinely submitted information regarding the use of funds to ensure they are being spent appropriately. Additional compliance monitoring will take place as the projects progress.

**COVID Testing and Pandemic Response:** Many of these projects have been up and running prior to the ARPA funding. With previous funding obtained under the CARES Act, COVID Testing and mitigation efforts were put in place. Those projects and additional projects were funded with ARPA monies to continue this important work. In addition to COVID Testing, we have developed projects to assist in vaccine distribution to promote COVID-19 vaccination and increase vaccination rates throughout Delaware. Other projects under this category are in the early developmental stages and are aimed at future pandemic response and prevention. Compliance monitoring is underway for several of these projects to ensure accurate record-keeping and appropriate use of funds.

Higher Education: Delaware has partnered with Delaware State University (DSU), Delaware Technical and Community College (DTCC), and the University of Delaware (UD) to complete multiple ARPA projects. These projects are in the early phases of design and have not begun development yet. These projects will consist of capital upgrades related to technology purchases and building construction for new facilities. Routine meetings have begun and will continue to be held to discuss the progress and

compliance for each project. These projects will serve the students of each higher education facility as well as the citizens of Delaware through the research that will be conducted in the new facilities.

Hospital & Long-Term Care Facility Support: The awards for these projects have been issued and facilities have begun to spend money on COVID-19 mitigation as well as staff recruitment and retention. Each facility will provide details showing how the funds they received were spent. For instance, if bonuses were provided to recruit or retain employees the amount of the bonus per employee and in total would be provided. Monitoring efforts will be in place to ensure the goals of this project, to mitigate COVID-19 while reduce staff shortages, are met.

Mental Health Services: These projects are in the award process and have not begun work as of June 30, 2022. Each project submitted a detailed worksheet stating what is intended to be completed. During the compliance reviews that will be conducted, it is our intent to ensure the funds are spent appropriately and as they were stated to be spent. We will review the services provided and the demographics associated with the services that have been provided. Premium Pay & Public Sector Workforce: These projects were created to reduce staff turnover and assist with resolving the staffing crisis for hard-hit sectors within the workforce. These projects are reviewed to ensure the funds are spent appropriately and bonuses are paid within the guidance provided in the US Treasury Final Rule.

**Revenue Replacement:** These projects are still being considered as the State looks to secure economic development projects that will have a lasting impact. No projects have begun as of June 30, 2022.

**Safer Delaware:** Several Safer Delaware projects are in the award phase, with no funds allocated as of June 30, 2022. The goals of these projects are to reduce gun violence and safer communities throughout Delaware.

**State Capital:** Several of the projects in this category have begun but are in the design or early development stages. Projects in this category include new construction or renovations, HVAC upgrades, or software system developments. Each project will be monitored to ensure funds are spent appropriately and the projects progress in a timely manner. A new Hospital for the Chronically III, Public Health laboratory, DNREC laboratory, and Food Warehouse will be developed to better serve the citizens of Delaware.

**Workforce Development:** The Forward Delaware Workforce Development Fund was allocated \$50 million in APRA funds, and several projects have been awarded to date. We have collected equity-based intervention data from the projects that have begun and will continue to collect information as projects progress. Each project will be monitored to ensure compliance with the terms of the project and use of funds.

#### Project Overview

• The State of Delaware Department of Technology & Information (DTI) released a grant application to award grant funds to construct broadband infrastructure as part of the Delaware Broadband Infrastructure Grant DBIG program. Through this grant application process DTI seeks to provide federal funding to private partners that commit to building expanding and sustaining new broadband service capabilities to unserved rural areas throughout the state cover the last mile connections throughout Delaware. DTI's analysis of which areas are unserved can be found in the 2020 Delaware Broadband Strategic Plan. It is estimated that there are more than 11,600 homes and businesses in Delaware that lack high-speed wired broadband access.

#### Use of evidence

• Funding to create new and extend existing broadband services to interconnect the state with high quality broadband services. This program specifically targets underserved populations and geographic locations. ARPA Delaware will collect quarterly project status updates and compliance reviews, meeting with the project leads as well as reviewing sample invoices and transactions. Quarterly project reviews and compliance checks will be used to ensure funding is used expeditiously and accordance with the project plan. The number of households connected and the demographic data for each will be collected and studied. 433 miles are planned to be deployed with 4,482 locations to be severed with a total of 4,318 locations receiving a minimum of 100/20 Mbps and scalable to 100/100 Mbps post SLFRF investment. ARPA Delaware will review and capture the completion statistics and implementation data to ensure the project projections are accurate and achieved.
