The following is a Constitutional Amendment and does not require the Governor's signature:

SS #1 for SB #11 (6/30/24) – AN ACT PROPOSING AN AMENDMENT TO ARTICLE I OF THE DELAWARE CONSTITUTION RELATING TO CRIMINAL PROCEDURES. (Sponsors: Sen. Townsend & Rep. Chukwuocha). (Volume 84, Chapter 283, Laws of Delaware).
